Sub: Affiliated D.PEd Colleges – MSR Institute of Physical Education, Khasara No.223/A,F,H,232/C&V, Durajpally (V&P), Chivemla (T), Suryapet Dist. 508 213 Grant of Extension of provisional affiliation for the Academic year 2023-24 – Orders Issued.

Based on the recognition accorded by the National Council of Teacher Education, Bangalore and the recommendations of the University Scrutiny Committee, the University has accorded approval for grant of extension of provisional affiliation to MSR Institute of Physical Education – Khasara No.223/A,F,H,232/C&V, Durajpally (V&P), Chivemla (T), Suryapet Dist. 508 213 for the Academic year 2023-24 to offer D.P.Ed Course with an intake of 50 subject to the fulfillment of the following conditions and general rules of affiliation:

CONDITIONS:

- 1. As per NCTE-2014 norms, for an intake of one basic unit of 50 students, there shall be 6 full time Sports Trainer 4 (part time), Yoga Trainer 1 (part time), Dietician 1 (part time) faculty numbers which is mandatory to run the course.
- 2. Infrastructure and the area required for running D.P.Ed. College is about 1500 sq. /mts.
- 3. 1+4 staff should be appointed through duly constituted selection committee.
- 4. Compliance report is to be submitted.
- 5. Books worth of Rs. 10,000/- to be purchased.
- 6. To appoint teaching staff through duly constituted selection committee as per NCTE norms representing all Methodologies and obtain the Renewal / Approval from the Registrar, MGU for the existing / New staff including Principal at the beginning of the Academic year 2023-24. The details of approved lecturers along with their photographs are to be uploaded to University website www.mguniversity.in and a hard copy to be submitted to the University.
- 7. Computer lab should be strengthened by purchasing required number of computers along with required software's.
- 8. Salaries should be paid through bank only.
- 9. The management has to fulfill the conditions as per the NCTE recognition norms and procedures 2014.
- 10. Teaching diaries and student attendance registers are to be maintained properly.
- 11. Three Governing Body meetings are to be conducted in an Academic year associating University nominee and the resolutions are to be submitted through University nominee.
- 12. The compliance report with relevant evidences must be forwarded through University nominee on the Governing Body and to be submitted in time to the University.
- 13. The Purchase of guides or study material in any form cannot be considered as part of the books purchase for the Library.

The Management is directed to submit the compliance Report on the fulfillment of the above conditions within one week with documentary evidence wherever necessary, through Governing Body member nominated by the University in the following prescribed proforma.

GENERAL CONDITIONS TO BE FULFILLED BY ALL COLLEGES:

- 1. That they should appoint teaching staff through duly constituted selection committee as per MGU norms, associating the University Nominee on the Selection Committee and Subject Expert representing all Methodologies and obtain the Renewal/Approval from the Registrar MGU for the Existing / New staff at the beginning of the academic year whenever required.
- 2. As per NCTE norms the Management has to shift the College to its own premises within (3) academic years from the date of establishment.
- 3. To provide spacious rooms for classes and laboratories and separate toilets for boys and girls as suggested by the Scrutiny Committee.
- 4. Consolidated attendance statement is to be prepared every year and submit to the University.
- 5. It is made clear to all the colleges that if the above conditions are not fulfilled by the college(s) within the stipulated time, such colleges(s) will be disaffiliated under intimation to NCTE/State Government.
- 6. To appoint a qualified librarian
- 7. Attendance registers and teaching diaries are to be maintained properly. Attendance to be marked in the class room only.
- 8. College should follow MGU almanac strictly.
